The Managing Trustee shall maintain or cause to be maintained all account of income from trust properties, operate the bank accounts of income from trust properties, operate the bank accounts from trust and incur expenditure for the administration of the Trust. Collect funds and take **All Action And Legal Or Other Proceedings Before Any Court Of Authority** whatsoever in the name of the trust as may be decided by the Board of the Trustees from time to time.

The **President** delegates all or any of the foregoing powers to anyone or more of the trustees and may revoke delegation of such authority anytime.

The Managing Trustee may be permitted to draw such remuneration as may be determined by the Board of Trustees, but such remuneration shall not be altered to his prejudice during his terms of office.

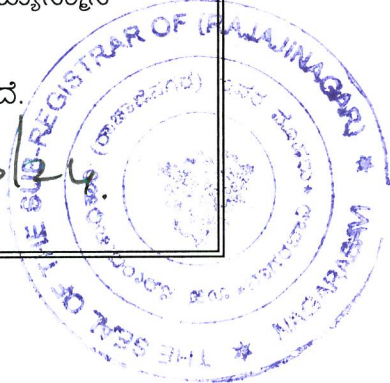

Life Trustee discharge such functions and duties as assigned from time to time by the Managing Trustee, which he/she claims for the interest of smooth functionary of the Trust

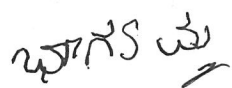
3) **CUSTODY OF DOCUMENTS**

The Managing Trustee or his/her nominee or the Security of the Trust of so authorised by the Board of Trustee shall take the custody of all documents, deeds of title a relating to the trust properties and investment and books of account and any other records relating to the shall be responsible for the preservation of the same. They shall ordinarily be preserved and maintained at the Registered Office of the Trust.

4) **ACCOUNTS**

Official Year: The official year of the Trust will be from **1st April to the end of 31st March every year**. The accounts closed financial year and the financial statements drawn up. The same shall be duly audited by a Chartered Accountant. Board of Trustee shall have power to issue appeals to raise funds and fulfil all formalities incumbent upon it. To accept subscription, grants contributions, donations, guarantees, gifts and bequest, to raise Credit/ Loan etc. from any financial institution including Foreign Foundations and other organisation instituted by the Government of India, Department of Women and Child Development for meeting for the Micro Credit needs of poor women for further activities of the Organisation/Institution whose objects are similar to those of this Trust and which enjoys the recognition under 80(G) of the Income Tax Act 1961 or other similar statues of Foreign Countries as amended from time to time. The Trust may also undertake similar activities on collaboration.

7) **RIGHT OF THIRD PARTIES OR BENEFICIARIES:**

The allotment, distribution and utilisation of funds, donations, gifts, contributions, subscriptions etc., meant for carrying out the objects of the Trusts shall be at the absolute discretion of the Trust Development and it shall not be questioned by the benefits of the Trust Funds or by other.

8) **AMENDMENT TO THE TRUST DEED:**

The settler shall have power to amend, alter repeal or add time to any term clause or provisions of this Deed by a 3/4 majority decision provided that such amendment alteration or addition or repeal shall not be contrary to the provisions of the Income Tax Act 2(15), 11 to 15 and 80(G) any such amendment shall be carried out only with the prior approval of the jurisdictional Commissioner of Income Tax.

10) DISSOLUTION OF THE TRUST:

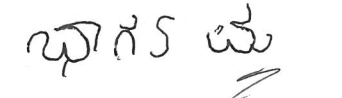
